Evaluation of Delaware's Opportunity Grants Program Jeff Klein (Lead Researcher)

CRESP partners with the Delaware Department of Education (DOE) to evaluate the Delaware Opportunity Grants program. The Opportunity Grants program intends to provide additional resources for English learner and lowincome students in Delaware schools. CRESP's evaluation of the Opportunity Grants program assesses the program's impact and identifies best practices related to schools' use of Opportunity Grant funds. This evaluation is funded through the Delaware Department of Education.

The CRUE/Research for Schools (R4S) project involves a large-scale nationally representative survey of over 10,000 staff from 300 schools to document how and when schools use research, and the conditions that promote or inhibit research use in schools. Leadership Education for Neurodevelopmental and Related Disabilities (LEND) Evaluation

CRESP partners with the UD Center for Disabilities Studies (CDS) for the evaluation of the LEND project (a CDS program which offers integrated training to pre-professionals and professionals pursuing fields connected to autism spectrum disorder and other developmental disabilities). CRESP's evaluation provides information to LEND staff about program implementation that enables them to continuously improve and shape the project, and to gauge the extent to which the program is on track to meet its goals. The project is funded by the U.S. Department of Health and Human Services, Health Resources and Services Administration.

Healthy Beverages in Kids' Meals Policy Research

Allison Karpyn (CRESP Lead Researcher)

In the fall of 2018, Wilmington, Delaware enacted a policy requiring that healthy beverages (i.e., milk, water, 100% juice) be the default choices at restaurants serving bundled children's meals. CRESP researchers collected baseline data about children's meal beverages at affected restaurants in December 2018, prior to policy implementation. Six months later, in July 2019, CRESP researchers collected data post-policy implementation. Also in 2019, the state of Delaware passed a healthy kids meal beverage policy. Accordingly, CRESP's future research plans include conducting statewide pre- and post-policy assessments. This study is funded by the Robert Wood Johnson Foundation.
